

## To be eligible you must...

---

- Report the incident to law enforcement within 3 days of the incident
- Submit your claim for compensation within 2 years of the incident
- Cooperate in the investigation and prosecution of the crime

# Financial Help May Be Available through the Nebraska Crime Victim's Reparations program

## What is the Crime Victim's Reparations (CVR) program?

The CVR program is a program which became effective in 1979 in the State of Nebraska to help victims of crimes who have been injured or have suffered a financial loss as a result of the crime.

### Who is eligible?

- A victim who suffers bodily injury
- A dependent/legal representative of a homicide victim
- A parent/guardian who is responsible for medical expenses of a minor
- A person who was injured in a DUI or the driver intended to hit the victim
- A person who was injured while aiding a crime victim or law enforcement officer

### Who is not eligible?

- A person injured in a motor vehicle accident
- A person whose actions caused the incident and/or injuries
- A person who helped the offender commit a crime or was injured/killed while committing a crime

### What may be paid?

- A maximum of \$25,000 per person per claim
- Medical expenses directly related to the incident
- Funeral expenses as a result of the incident (\$5,000 max)
- Lost wages for the victim while in a doctor's care
- Loss of support of the victim for an eligible dependent/dependents
- Counseling expenses for the victim and witnesses of the incident (\$2,000 max)

### What is not covered?

- Property loss
- Pain and suffering
- Expenses not directly related to the incident
- Expenses paid by the offender, private or group insurance, public funds, or other assistance

### Is an attorney needed?

- No, you do not need an attorney to file a claim. The Hearing Officer or CVR Committee may allow some attorney fees up to 5% of the awarded amount

### Please Submit:

- Visit the Crime Victim's Reparations program website at [ncc.nebraska.gov/crime-victim-reparations](http://ncc.nebraska.gov/crime-victim-reparations) to access the CVR application.
- Itemized billing statements with dates, procedures, and cost from the service provider
- Any other information requested by the CVR Committee or Hearing Officer
- For loss of wages claims, submit:
  - Copies of three paystubs immediately prior to the incident
  - Letter from employer confirming weekly hours worked, wage, and any compensation paid
  - Copy of your doctor's release to return to work
