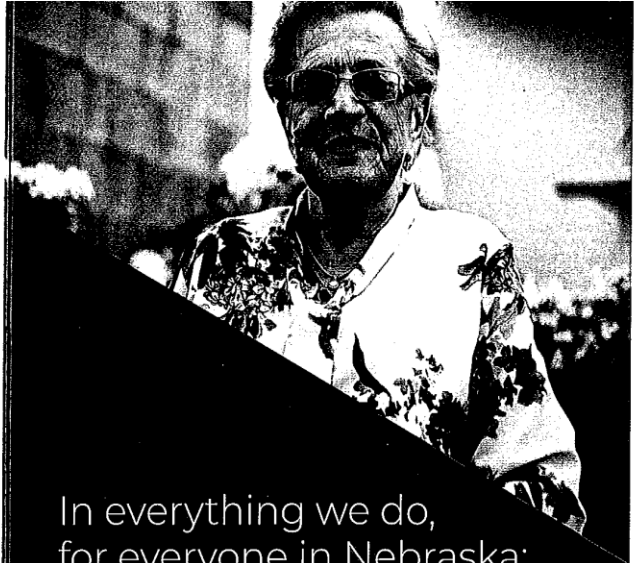

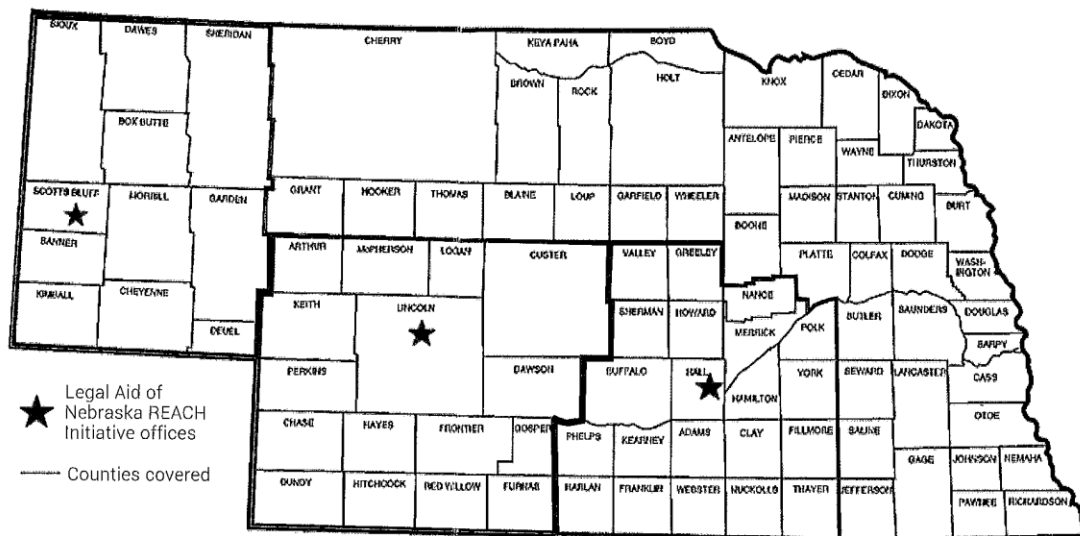


## REACH Initiative

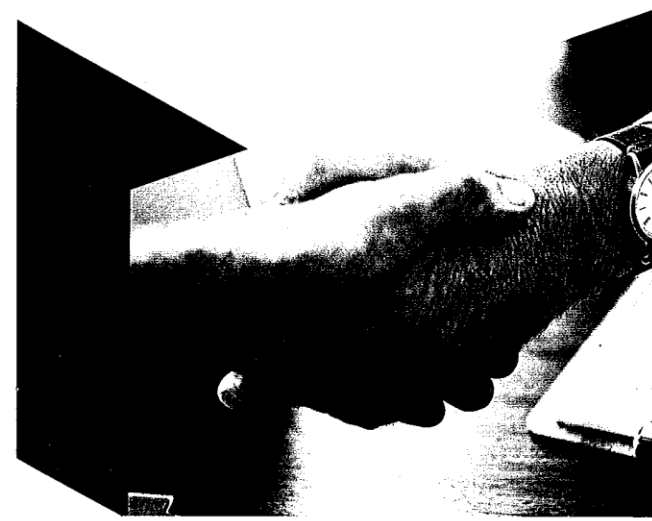
## HOW WE HELP

## WHAT WE HELP WITH

The REACH Initiative provides **FREE** civil legal services to victims of domestic violence and victims of elder abuse and financial exploitation to address immediate health and safety needs.

The most common issues include but are not limited to:

- Protection orders including domestic abuse protection orders, sexual assault protection orders, and harassment protection orders
- Divorce
- Paternity
- Custody
